By now, you have probably heard about the DEP Bureau of Radiation Protection Registrant Responsibilities for CE in Radiation Safety. This requirement is found in Title 25 of the Pennsylvania Code in section 221.11(b). In February of 2009, a Technical Guidance report was issued that provided information about the requirements.

In July of last year, DEP sent a copy of the regulations to all offices licensed to provide X-Rays in PA. If you've been wondering how you can comply with the requirement and where you need to go, look no further.

requirement. It will be held on Wednesday, November 9, 2011 at Genetti Manor in Dickson City, PA. There will be two sessions --- a morning (8:00 a.m. – 12:30 p.m.) and afternoon (12:30 p.m. – 5:00 p.m.). This would be a great time to send anyone in your office who works with X-rays. The cost is \$30 per member doctor and \$10 per staff member. We anticipate that it will be sold out, therefore, registration will be on a first come, first served basis. A registration flyer will be mailed in August.

The course will focus on the management of ionizing radiation in dental practice with special emphasis on the following topics:

- a review of radiation, units of measurements of exposure and dose
- the ALARA concept
- shielding, facility design and records requirements
- occupational dose and the pregnant worker
- minimizing patient radiation dose
- digital imaging quality assurance
- preventive maintenance programs
- and laws that regulate the use of ionizing radiation in dental practice.

#### NEWS FROM THE PDA Action Alert - Cosponsors Needed for Non-Covered Services Bill

Sen. Kim Ward (R-Westmoreland) is sending a memo to her colleagues in the Senate requesting that they cosponsor legislation prohibiting insurers from capping non-covered dental services. We need bipartisan support for this legislation for it to pass the General Assembly.

Please contact your Senator immediately and request that he or she cosponsor this bill. A bill number has not yet been assigned so you may simply refer to the bill as "Sen. Ward's Non-Covered Dental Services legislation" when communicating with your Senator.

Use the talking points below when speaking to your Senator.

Talking Points:

It is fundamentally unfair for insurers to dictate fees on procedures they have chosen not to cover. This begs the question: Why aren't insurers improving their benefit packages by covering more dental services?

Insurers will say they are saving money for patients. But there is only one cost of operation and one fee reflecting the cost of providing a service. Dentists may be forced to shift costs to other patients, reduce the number of services offered or make different treatment decisions to minimize the impact this policy will have on their practices.

The terms of a contract between an insurer and participating provider only apply to the services covered under their plans. When that point is reached, any financial and treatment decisions should be made between the dentist and patient only.

Limiting fees on non-covered services could have a troubling impact on dental practices, particularly those in low-income and underserved areas.

New dental school graduates may seek employment in other states with more friendly insurance business practices.

This bill contains a provision that would require dentists to charge the discounted fee on covered services once patients have met their maximum allowance. PDA accepted this language to garner support from key legislators who are in positions to "kill" the legislation if this language was not included. PDA believes we are now in a better position to achieve our goal to prohibit insurers from capping non-covered services. Generally, less than three percent of patients exhaust their annual benefits.
