## Mom-n-PA

Won't you join us as the Third District hosts the 2019 Mom-n-PA mission? Plans are being made for this exciting event slated to occur June 2019 at the Mohegan Sun Arena.

The MOM-n-PA mission is a large-scale dental clinic where dental treatment is provided at no cost to individuals who cannot afford dental care. Treatment is provided on a firstcome, first-served basis and patients do not preregister.

The inaugural two-day mission took place in Philadelphia in 2013. With the help of 1,001 volunteers, MOM-n-PA provided \$850,000 in free dental care to 1,820 patients. The second mission



took place in Allentown, Pennsylvania where they provided care to 2,047 patients and 1,020 volunteers donated \$1,004,179 worth of care to those in need. The 2015 mission took place in Harrisburg where 976 volunteers

provided \$875,905 worth of care to 1,705 patients. The 2016 mission took place in Pittsburgh. 1,008 volunteers and our sponsors provided over \$841,959 worth of dental care to the underserved! In the 2017 mission in Erie, there were 736 underserved patient visits and \$600,798 worth of donated dental care!

As of today, MOM-n-PA has completed 25,925 procedures on 7,255 patients. The total value of dental care donated is \$4,172,841 and they have had 4,005 volunteers.

## ADA Applauds CMS Decision To Remove Part C, D Requirements.

On November 16, 2017, The Centers for Medicare and Medicaid announced proposed changes to Medicare drug plans, including rescinding the requirement that dentists enroll in or validly optout of Medicare in order for a Part D drug prescriptions to be covered. The proposed rule also contains changes to Medicare Part C, including rescinding the current provision requiring dentists be enrolled in Medicare in order to provide supplemental services to patients enrolled in Part C, also known as Medicare Advantage plans.

The ADA News (12/5/17, Garvin) also reports CMS "has not rescinded the two-year opt-out period for providers, meaning dentists who acted in good faith and chose to opt out of

the program are still prohibited from accepting payments for services covered by Medicare Part B or Medicare Advantage plans." As a result, the claims of patients who receive care from a provider who opted out within the past two years will still be denied.

#### Online Sign-Up

#### Register to Receive PDA Texts

In an effort to better communicate with us, the PDA would now like to communicate important information through texting, however they will need your permission to do so. Please go to the PDA website, and from the homepage, click on "Membership," and then click on "texting authorization." If you would rather a paper form to fax to the PDA, you can print one from the site.

#### **CHIP**

The Pennsylvania Department of Human Services (DHS) is

implementing the Affordable Care Act (ACA) Provider Screening and Enrollment provisions which require all providers who render services to CHIP enrollees to enroll with DHS. Federal regulations require states to screen CHIP providers the same as it does Medical Assistance (MA) providers. The deadline fast approaching!

To enroll, providers must complete an enrollment application appropriate for their provider type and submit all required documents. If a provider is already enrolled in the MA program, the provider does not need to enroll again in CHIP.

CHIP-only providers will receive a provider ID number but they will not in any way be identified as MA providers. DHS officials warn that CHIP-only providers who wait to enroll until close to the December 31, 2017 deadline run the risk of disrupting services to patients and claim submission and reimbursement. CHIP-only providers are strongly encouraged to submit an enrollment application as soon as possible, so DHS staff has time to process the application before the deadline.

#### Assignment of Benefits Legislation

PDA has lobbied for years for the passage of assignment of benefits legislation, which would require insurers, on patients' request, to assign

benefits directly to dentists, even if they are non-participating providers. On October 24, PDA accomplished a monumental task while contending with intense opposition from insurance lobbyists. The Senate Banking and Insurance Committee passed SB 373, PDA's assignment of benefits legislation, with a vote of 9-6.

The fight is far from over. PDA expects the insurance lobby to ramp up its efforts to "kill" the bill even more as SB 373 moves to the Appropriations Committee for consideration, then the full Senate for a vote. Action on our part is necessary to pass this bill in the Senate and over to the House of Representatives. The insurance industry has many lobbyists and deep pockets. But the voice of organized dentistry is thousands strong, and represents both dentists and patients. Senators just need to hear from all of us, and they need to hear from us soon. If they don't, your Senator will assume this legislation is not important to dentists, and there is a good chance the insurance lobbyists will prevail and that SB 373 will not move any further in the legislative process.
