Oil Pulling

I'm sure many of you have received questions from your patients recently regarding oil pulling and charcoal toothpastes. Following is a blog from the ADA that may help when responding: *"Oil Pulling, Charcoal Toothpastes Among Fads 'Wreaking Havoc' On Teeth.*

The Daily Mail (12/26, Thompson) lists several dental fads that dentists say are "wreaking havoc with people's teeth." For example, while some celebrities swear by beginning each day with a glass of hot water and lemon, dentists warn that sipping the beverage regularly could erode enamel due to its acidity. In another example, the article states that although some oil pulling advocates are endorsing the ancient practice as a way to improve

oral health and whiten teeth, there is "no scientific proof" to support these claims. Similarly, "despite the recent surge in charcoal toothpastes on the market," a dentist notes that "there is inadequate data to prove the safety and efficacy claims of charcoal and charcoal-based oral health products."

Dental professionals can direct their patients to MouthHealthy.org, ADA's consumer website, for evidence-based information about teeth whitening, including information on natural teeth whitening methods. MouthHealthy.org also provides information on oil pulling, noting that "the American Dental Association does not recommend oil pulling as a dental hygiene practice."

A literature review published in The Journal of the American Dental Association found insufficient evidence to support the efficacy claims of charcoal products."
