
### Sign Up for Text Meeting Reminders

#### PDA Scores A Legislative Victory as Session Wraps Up

PDA took the lead in a health care provider coalition lobbying for HB 2241, legislation limiting the time frame in which insurers may retroactively review and deny claims to 24 months, with some exceptions. Current law allows insurers an indefinite amount of time to demand providers repay previously paid claims. We are happy to report that the General Assembly passed HB 2241 on its last day of session this year and that it will be sent to the Governor for his signature. The coalition has assurances from the Administration that the Governor will sign and enact this legislation; once doing so, the law becomes effective in 60 days. We will notify members when Governor Wolf signs HB 2241 and we know the effective date.

Passing this meaningful insurance reform wasn't easy. It took many years in which PDA provided testimony and data to the legislature, participated in stakeholder meetings with other health care provider groups, insurers and the legislators, and cultivated support from leaders in the House and Senate to "move" the bill. Our collective work paid off due to efforts made by staff, lobbyists and volunteer members. Many thanks to those of you who responded to PDA's action alerts requesting that you contact your Representative and Senator. Passage of HB 2241 illustrates how advocacy through organized dentistry pays off--helping you maintain a viable dental practice!

#### General Assembly Passes Legislation Requiring CE in Opioids

The General Assembly passed SB 1202, legislation that requires the following of health care providers:

• Applicants for an initial license must obtain at least two hours of education in pain management or identification of addiction, and at least two hours of education in the practice of prescribing or dispensing opioids. They may complete this requirement as part of their professional degree educational program or from a continuing education (CE) program taken within 12 months of obtaining an initial license or certificate.

• Dispenses and prescribes applying to renew their licenses or certificates must complete at least two hours of CE in pain management, identification of addition or the practice of prescribing or dispensing of opioids as a portion of the total CE required for biennial renewal.

Licensing boards are tasked with working with the Department of State to approve courses for pain management, identification of addiction, and the practices of prescribing and dispensing of opioids

PDA expects Governor Wolf to sign SB 1202 into law before the end of the year. Once signed, the law will become effective in 60 days. We will continue to apprise you of developments as the licensing boards begin the process of approving curricula and CE courses.

#### Pennsylvania law requires clearances when interacting with or treating children

New provisions in Pennsylvania's Child Protective Services Law require individuals to obtain several clearances every five years, in the course of their employment or volunteer activities, if they have either:

- Direct contact with children because they provide care, supervision, guidance or control of children, AND
- Routine interaction with children defined as "regular and repeated contact that is integral to a person's employment responsibilities."

To help determine which members of your dental office staff need certifica-

tions, you may want to consult with your insurance carrier or attorney. However, PDA advises members to err on the side of caution and have all staff having any contact with children obtain the certifications.

The following certifications are needed to comply with this law:

- Report of criminal history from PA State Police
- Child Abuse History Certification from PA Department of Human Services
- Federal criminal history from FBI
- Use these websites for instructions and links to apply for these certifications:

You are required to keep copies of your certifications, and those of your employees. You must also require prospective employees to produce these documents prior to employment. Clearances obtained for volunteer purposes cannot be used for employment purposes, but employment clearances are acceptable for volunteer activities.

To ensure that you are in full compliance with Pennsylvania's child abuse laws, be sure to register for PDA's custom designed CE course (Child Abuse Recognition and Reporting Requirements for Dental Professionals), which is offered in multiple locations across the state for both members and your professional dental staff. This program will fulfill the two-hour training requirement and count toward the CE credit hours you need to renew your dental license in March 2017.
