## Pennsylvania Dental Association

As of late, there have been requests from several members to review child abuse requirements. We hope this helps:

#### Pennsylvania law requires clearances when interacting with or treating children:

New provisions in Pennsylvania's Child Protective Services Law require individuals to obtain several clearances every five years, in the course of their employment or volunteer activities, if they have either:

- Direct contact with children because they provide care, supervision, guidance or control of children, AND
- Routine interaction with children defined as "regular and repeated contact that is integral to a person's employment responsibilities."

To help determine which members of your dental office staff need certifications, you may want to consult with your insurance carrier or attorney. However, PDA advises members to err on the side of caution and have all staff having any contact with children obtain the certifications. The following certifications are needed to comply with this law:

- Report of criminal history from PA State Police
- Child Abuse History Certification from PA Department of Human Services
- Federal criminal history from FBI Use these websites for instructions and links to apply for these certifications:

You are required to keep copies of your certifications, and those of your employees. You must also require prospective employees to produce these documents prior to employment. Clearances obtained for volunteer purposes cannot be used for employment purposes, but employment clearances are acceptable for volunteer activities. To ensure that you are in full compliance with Pennsylvania's child abuse laws, be sure to register for PDA's custom designed CE course (Child Abuse Recognition and Reporting Requirements for Dental Professionals), which is offered in multiple locations across the state for both members and your professional dental staff. This program will fulfill the two-hour training requirement and

count toward the CE credit hours you need to renew your dental license in March 2019. Here's a link to course information:

#### PDA's Assignment of Benefit Legislation Passes the Senate

On January 23, 2018, the Senate of Pennsylvania passed SB 373, PDA's legislation requiring insurers to assign benefits, on patient's request, to non-participating dentists. SB 373 now moves to the House Insurance Committee in the House of Representatives.

Assignment of benefits legislation is PDA's top priority this legislative session. PDA's lobbyist, staff and volunteer leaders drafted the legislation, found sponsors to introduce bills in both the House of Representatives and Senate, and spearheaded negotiations in both chambers to garner enough support for legislative leaders to begin moving the bill through the Senate. It is a monumental feat moving an insurance bill, one ardently opposed by the insurance lobby, through the legislature. PDA's strength in advocacy proves that your dues dollars are hard at work!

PDA is very optimistic that the House of Representatives will pass SB 373 before the end of session in late fall. Help us keep the momentum going passing this important insurance practice reform legislation to the Governor for his signature! Stay tuned for PDA's action alerts requesting that you contact your Representative to educate them about assignment of benefits and the need to support SB 373. We need a united front to counter the insurance lobbyists hard at work opposing this bill.

Your participation in this process is essential to moving SB 373 through the House of Representatives and on to Governor Wolf for his signature. Please contact your Representative today and request his or her support for SB 373. It will only take a few minutes of your time--we provide talking points below . The PDA provides an easy link and sample letter to send to your state representative. To do so, sign onto the PDA website and click on the scrolling menu titled "Assignment of Benefits."

They need to hear from as many dentists as possible as to why it is so important for Pennsylvania to pass assignment of benefits legislation!

PDA thanks the hundreds of you who responded to our action alerts on this legislation. This victory illustrates how the collective voice of organized dentistry can make a positive difference for your profession and patients!

#### REASONS TO ENACT ASSIGNMENT OF BENEFITS

- Some patients cannot see their dentist of choice because some insurance companies do not directly pay the non-participating provider, and the patient cannot afford to pay for services upfront. Dentists who do not require advanced payment may never be paid for services rendered. This insurance practice unfairly inhibits patients from seeking care from their dentist of choice, even though they are paying for a benefit that should be able to be applied to any provider, regardless of whether or not the provider participates with the insurance plan. The insurance is a purchased product and belongs to the patient.

- Absence of assignment of benefits legislation forces patients to pay upfront for treatment they may not be able to afford. This can be particularly difficult for divorced or separated parents, single parents and lowincome families. It would be much easier for patients to have the ability to assign their dental benefit directly to the provider.


- Parents who are divorced or separated may experience the problem where one parent has custody of a child, while the other parent carries the insurance. The latter may never send the insurance check to the custodial parent, who had to pay for services upfront. Faced with this situation, many custodial parent postpone or avoid care altogether. This could also impact the dentist, who sympathizes with the parent and sees the child without requiring advanced payment. Often, these dentists are never paid.

- Patients residing in rural areas are placed at a disadvantage as there may only be a handful of dentists who are in-network. Patients may have to incur more traveling time and expense to seek treatment from an in-network provider, rather than being treated by a non-participating dentist who practices in closer proximity.

- Twenty-three other states have enacted assignment of benefits laws.
