## SDDS Presents Scholarship Awards

The Scranton District Dental Society is pleased to announce that it has selected Eric Brazon as the 2014 recipient of both the Dr. Todd M. Angelo Memorial Scholarship and the Dr. Bernard Shair Award.

The Dr. Todd M. Angelo Memorial Scholarship is a cash gift funded by the SDDS, The Scranton Area Foundation, and private donations in memory of Dr. Todd Angelo who suddenly passed away in November 2011. The scholarship is administered by the Scranton Area Foundation and presented to a University of Scranton student who has been accepted by a dental school and who shows tremendous promise in the field of dentistry. This award serves as a reflection of Todd's dedication, service and love of dentistry.

The Ben Shair Award is a cash gift funded by the SDDS and an endowment fund founded by the

family of Dr. Bernard Shair (who passed away in 1982) and administered by the Scranton Area Foundation. It is presented to a University of Scranton student who has been accepted by a dental school and shows tremendous promise in the field of dentistry.

Brazon, featured on the Dean's List since 2010, will graduate with a Bachelor of Science degree in Biology. He will attend the Temple University Kornberg School of Dentistry in Philadelphia, PA in the fall.

Brazon currently resides in Wilkes-Barre, PA with his parents Dr. and Mrs. Richard and Barbara Brazon. He is a member of the University's Health Professions Organization, as well as Alpha Lambda Delta and Alpha Epsilon Delta (National Health Pre-professional Honor Society). He is the recipient of the University's Loyola Scholarship.

Along with working under his father

at Keystone Dental Center in Scranton, PA, Brazon also spent two years learning under Doctors Giallorenzi, Kotchick, and Burns of Valley Oral and Maxillofacial Surgery, Scranton, PA. He currently volunteers his time on Saturday evenings at Pittston YMCA, teaching children fundamental skills in basketball and assisting where need during the summer.

# President's Letter

In the SDDS, "spring work is going on with joyful enthusiasm," to quote the naturalist author John Muir. With the arrival of warmer winds and yellow daffodils popping up, our society has marked a few wonderful celebrations already, with several more coming up on the calendar. We presented the Dr. Bernard Shair scholarship award and the Dr. Todd Angelo scholarship award to Mr. Eric Brazon at our general meeting in March, held in the DeNaples Center. In April, we commemorated our World War II veterans at the Colonnade. Special thanks to Dr. Joseph Kelly Sr. for his enthusiasm and leadership in organizing the event and to Dr. Justin Burns for planning such a great venue. In May, we celebrated the annual President's Dinner in honor of Dr. Amy Cravath at the Country Club of Scranton, and in June we will herald the arrival of summer with the annual golf tournament and clam bake.

As we prep our lawns and clean out our flower and garden beds, we also are reminded that spring is a time to sow seeds for future harvests. The SDDS is ahead of our fiscal goals this year. Likewise, the Pennsylvania Dental Association, a parent organization for our society, has made changes to run more dynamically and cost-effectively in the years to come. Our Third District delegates Drs. Kotchick and Karam, led by our 3rd district trustee Dr. Eli Stavisky and 3rd district president Dr. Matt Zale, recently arrived home from the 2014 PDA annual session in Hershey, Pa. This year, the House of Delegates, a large body of 87 member dentists, voted to eliminate itself as part of the governance model, a major change in the representative structure. The new model will consist of an Executive Branch to carry out administrative duties and directives, an elected Board of Trustees, composed of one member from each of the 10 districts, with voting power to pass resolutions, and, replacing the role of the House of Delegates, a new Council



of Presidents, to serve in an advisory role to balance and challenge the Board of Trustees. This change means that the governance model is smaller, less expensive to our membership, and can meet more frequently with a full quorum to address the ever changing management issues in dentistry in our state. Our organization decided upon this governance model after years of review and diligent study of effective leadership models. PA is one of the very first states to implement this change and I predict will be a leader in the new style of government.
