Wednesday, January 23, 2013 Dr. Joseph Massad: The Latest on **Dentures and Implant Overdentures**

Topics Include:

Day on the Hill By Dr. J.R. Karam



As a new member of PDA's government relations committee, I joined nearly 120 colleagues in Harrisburg on June 5th to talk with lawmakers about pertinent legislation that will affect the way we practice dentistry. In addition to meeting with legislators, the PDA held a press conference to bring media attention to important access-to-care issues, such as funding for the adult Medical Assistance and Donated Dental Services programs which face severe cuts starting in September of 2012. Day on the Hill issues of interest included:

HB 532: Requiring insurers to cover general anesthesia for young children and patients with special need. Shortly after the Day on the Hill General Assembly passed HB 532

HB1537: PDA is lobbying for legislation prohibiting insurers from capping non-covered dental services, believing that insurers have no right to interfere in the financial arrangements made with patients once the insurer's contractual obligations are met. This house bill was tabled in June; however, mutual language from both the insurance companies and the PDA suggests that this

bill will pass.

SB 388, now Act 65: Requires dentists to carry malpractice insurance at minimum of \$1 million per occurrence or claim and \$3 million per annual aggregate. A licensee must show proof of having purchased this amount of insurance to the State Board of Dentistry within 60 days of the bill's enactment on June 22.

PDA successfully lobbied to amend the legislation of Act 65 to include the following exemptions:

- Dentists maintaining an active license practicing clinically.
- Volunteer dentists in communitybased settings. but not
- Dentists whose employer provides coverage.

PDA learned that the following changes to adult MA will take effect September 30.

- Limits an examination and cleaning to one every 180 days.
- Eliminates coverage for crowns.
- Eliminates coverage for endodontics.
- Eliminates coverage for periodontal services.
- Allows one denture per lifetime, regardless of procedure code used.
