Jacobi Wealth, on Tuesday, October 18th at 6:30 pm. Rod's talk is entitled "Insights That Impact Your Wealth."



- Third party issues
- Government regulation
- Non-dentist providers
- Representing our interests on issues pertaining to the Affordable Care Act
- Health practitioner student loan forgiveness and refinancing

A hot topic right now involves United Concordia fee reduction. Following please find this article for our PDA website:

PDA Takes United Concordia Dental to PA Insurance Commissioner

In response to United Concordia Dental's (UCCI) recent decision to reduce fees, PDA is aggressively protecting our members' best interests by immediately pursuing a state investigation of this highly questionable action. Hearing your growing and serious concerns, PDA's legal counsel sent a letter to the Commissioner of the Pennsylvania Department of Insurance requesting an investigation of dental insurers' unfair policies, arguing that the uneven playing field in which insurers dominate is detrimental to both dental providers and the patients they serve.

PDA will continue to work on your behalf, making sure that policy makers understand how dental insurers' egregious practices impact dentists and your ability to render quality care, and the need for them to investigate and hold these insurers accountable. Please stay tuned to PDA publications and emails as we monitor this issue and determine further appropriate action to take on our members' behalf.

PDA expends a significant amount of resources advocating on your behalf in regards to thirdparty payer issues in the legislative and regulatory arenas...

...Our work has now shifted to the Governor's Administration and the regulatory front, where we will make our members' concerns with UCCI a top priority.

Listed below please find some other examples of PDA's legislative agenda for 3rd party payers:

- Prohibiting Insurances from capping fees for non-covered services
- Limiting time frames in which insurers may retroactively deny claims
- Lobbying for assignment of benefits

- Advocating for more funding in the states MA program
- Supporting legislation that would allow dentists to collectively negotiate contract terms with insurers.
