"Regardless of the patient's age, sex or reason to be present in our office, the one certain professional action performed at each and every patient visit is the act of recording details of that visit in the "dental patient record." For the majority of us, this is quite routine and rarely read by anyone other than the dentist and/or

the dental staff. What is entered into that patient record varies in a similar manner to how each of our practice policies varies. Ultimately, the goals of each are very similar; providing the best possible patient treatment and accurately recording all the pertinent details regarding that patient's treatment. However, on occasion, what is recorded for each patient may become subject to review by others not directly related to our individual practices."

Act 65 Requires Dentists to Carry Malpractice Insurance

In June, Gov. Corbett signed into law SB 388, now Act 65, legislation that requires dentists to carry malpractice insurance at minimum of \$1 million per occurrence or claim and \$3 million per annual aggregate. A licensee must show proof of having purchased this amount of insurance to the State Board of Dentistry.

PDA successfully lobbied to amend the legislation to include the following exemptions:

- Dentists maintaining an active license but not practicing clinically.
- Volunteer dentists in communitybased settings.
- Dentists whose employer provides coverage.

Act 65 took effect on August 22, 2012. Rews It is our understanding that the State Board of Dentistry will most likely request proof of Dentistry will most likely request proof of adequate insurance coverage before or during the licensure renewal cycle and that it will look to see that licensees have met the August 22 deadline for purchasing the amounts now required. PDA advises dentists to show a good faith effort at compliance by updating your policies immediately and not to wait until it is time to renew policies.

President's Letter This time of year we are asked to vote for change

Are we ready for the changes to come? National healthcare was supported in 2010 by the AMA. The cost of dental education is over \$100,000



per year at some schools. New graduates join large practices to avoid startup costs of a new practice. Solos practitioners have more regulations, digital records are proposed as mandatory, and the legislatures push for "mid-level" providers and 3rd party reimbursement policy changes by fiat. Who is advocating for us dentists? Many older PDA members will shift to a reduced dues structure, and new members do not replace them. Dramatic changes from the "good ol' days." Are we ready for the changes to come? How can an individual dentist address these issues? Join us in organized dentistry to voice our consolidated concerns for the public, profession, and practice of dentistry. Come to our board meeting November 19th at 6 PM at Carl Von Luger Steak House on courthouse square in Scranton or attend our General meeting on October 16th at University of Scranton.

Does the public understand such issues? Recent political events demonstrate that "good will" goes a long way over a detailed discussion of the issues. Does the SDDS tooth fairy during National Children's Dental Health Month (NCDHM) convey a subliminal message of good will? Although the general public usually rates dentists high among all occupations, they also complain of access to affordable care. Even though most trust their personal dentist, they are wrongly willing to transfer that trust to a lesser trained experienced provider (i.e. "Mid-level provider"). We as dentists need to educate the public of these "toothless" efforts that miss real change.

The public is not aware of our discounted dental services to our needy patients or participation in the Jewish Family Services. We need to impress the public in a Big Way via the media, lobbying (come to "Day on the Hill" in June), and education (NCDHM in February). We are pleased to announce that Dr. Al Giallorenzi and his family have been named as the Host Family for Dr. Burne's Family to Family Thanksgiving Food Program. Started in 1986 by Dr. James Burne and his wife Mary Lou, along with their four children Jim, Mark, Mary, and Matthew, this local assistance program has been feeding families in the Greater Scranton area for over 25 years. This year, they plan on distributing 30,000 baskets which will feed about 15,000 people, more than half of whom are children. The food bill is expected to hit \$85,000.

According to Mary Lou Burne, "Each year the need gets greater with many working families living at or below the

poverty level. This food basket does help ease the burden and bring comfort and warmth at the most family-oriented holiday...Thanksgiving."
