Senate Approves Form 1099 Relief Measure

The ADA commended Senate approval Feb. 2nd of legislation offered by Sen. Debbie Stabenow (D-Mich.) to relieve dentists and other small business employers from tax reporting requirements scheduled to take effect after Dec. 31, 2011.

The Senate voted against repealing the overall health reform law that includes it.

Inserted as a revenue measure, Section 9006 of Public Law 111-152 amends the tax code to require that businesses report to the IRS payments for goods and services made by any vendor after Dec. 31, 2011, that exceed \$600 in a tax year.
