## **PDA Legislative Update**

A new legislative session has begun in Harrisburg with the new year, which makes this a great time to reflect on some of the legislative issues that Pennsylvania dentists faced in 2007 and 2008. It is also the best time to take a look at the ones that will be pursued in the current two-year legislative session.

The previous legislative session saw many "hot button" issues within the legislature of the Commonwealth and the current session will be no different. The following are just a handful of the past issues PDA's membership and lobbyists were successful in influencing:

• HB1257, which would expand EFDAs scope of practice, was moved through the House and will continue to be a topic for discussion.

• HB1649 was introduced, requiring the fluoridation of public drinking water and was lobbied extensively with legislators and the executive branch.

• Legislation regarding the use of dental amalgam was blocked, preventing undue hardships placed on dental professionals.

• SB246 regarding the ban of indoor smoking was passed in which PDA played a vital role.

• HB1898 was blocked which would have required patient brochures to be provided on mercury in dental amalgam statewide.

• HB494 was passed adding one dentist and one EFDA to the PA Board of Dentistry.

Overall, many positive steps were taken in protecting the interests of dental professionals practicing in the Commonwealth. However, now that a new legislative session is upon us we must strengthen our support and grassroots activism in the legislative process.

One can never do too much to assure that the voice of dentists is heard in Harrisburg. Membership and support within the structure of the PDA and PADPAC is the most effective way of assuring success in the legislative and regulatory process.

With the current legislative session only a few days old, PDA government relations staff and lobbyists have already begun the process of gaining support for dental legislation from our state representatives. Already in this session, over thirty pieces of legislation, having a direct affect on you as practicing dentist, are being monitored and will be continuously discussed at the Capitol and at legislative fundraisers.

Some of the more pressing issues being monitored involve: Insurance coverage for general anesthesia, MCARE abatement, PHEAA dental student loan forgiveness, health care professional shortages, insurance accessibility, retroactive denial, assignment of benefits, and many more.

It's important that Pennsylvania dentists pay attention to these issues and watch for news coming from government relations representatives at PDA. It is also important to support PADPAC, which provides vital funding to impact PDA's legislative priorities.

When the time comes direct contact from practicing dentists to their state representatives is the best way to assure that dentists are not forgotten within the legislative process.
