Jack Erhard Reappointed to PA State Board of Dentistry



Sincere congratulations to our very own Jack Erhardt who has been reappointed to the Pennsylvania State Board of Dentistry.

Jack is serving his fifth term as Board Chairman, marking his tenth year on the State Board.

The State Board of Dentistry, through the licensure process insures that dentists, dental hygienists, and, by means of certification, EFTA's are individuals qualified and suitable to practice in Pennsylvania. The Board issues, suspends and revokes licenses and certificates when deemed necessary. In addition, the Board supervises dentists, dental hygienists and EFDA's to insure that they are complying with licensure and certification requirements and the Board acts when complaints are made concerning these individuals. The Board develops standards of professional conduct, including continuing education requirements, in order to maintain a high level of integrity and performance in the practice of dentistry.

Jack is engaged in the private practice of dentistry in the North Pocono area. He is a CDCA (formerly NERB) license examiner and grader; Pennsylvania representative to the American Association of Dental Boards; and an ADEX (American Dental Examiners) PA representative. Jack creates and revises the restorative exam for ADEX.

He would like everyone to please remember to renew you license by March 31, 2019. The renewal process will be entirely electronic this renewal cycle. Practicing with a lapsed license may be viewed as unauthorized practice.

LICENSE RENEWAL DEADLINE: MARCH 31, 2019

Understanding licensure requirements can be confusing, due to the addition of mandatory CE courses every so often. Here is a breakdown of what is needed to renew your dental license.

30 hours minimum CE credits are required every two years to renew your dental license. Dental licenses are valid for 2 years until April first of the odd numbered year. This is the bare minimum in hours required, and there are certain CE courses that are now mandated for renewal. 15 of the 30 hours must be lecture hours, and the remainder can be completed online.

The child abuse course is now mandated, and 2 CE hours must be met for each renewal cycle. If you are a new applicant for licensure, 3 hours are required. Another mandated course is the Opioid course, and this is required if vou have or use a DEA number. For renewal it is a 2 hour CE requirement in the training of pain management, identification of addiction or the practices of prescribing or dispensing opioids. New licensees have 12 months to complete 2 hours of training in pain management or the identification of addiction, and 2 hours in the

practices of prescribing or dispensing opioids.

CPR courses are separate from CE required for re-licensure, and are not counted towards total CE hours. It is still mandated that you have an active CPR license.

If you are an unrestricted anesthesia or restricted permit I license holder, it is further required that 15 of your 30 hours are in anesthesia related courses. Dentists with restricted permit II do not need to fulfill any CE requirement in order to maintain the permit. ACLS/PALS training must also be maintained. Hello gang and Happy February!
